**1. Description**

The aim of the course is to provide an overview of European Legal History, so the student is able to acquire a basic understanding of the formation and historical evolution of the common European legal tradition from the Roman Antiquity to the modern European Union Law and reflect on the differences and similarities between the European systems of law. The course does not only focus on the private sphere of law, considering a broader political, constitutional and economical context.

**2. Course learning objectives**

Students should be able to:

1. Obtain a comprehensive overview of the different schools of legal thought and the traditional sources.
2. Critically analyse and reflect on European Legal History, its origins and development.
3. Understand the evolution of the different legal traditions in Europe, as well as the formation and evolution of a common European legal background, as a key social and cultural element of the European reality.
4. Compare and contrast different legal systems and identify their main characteristics.
