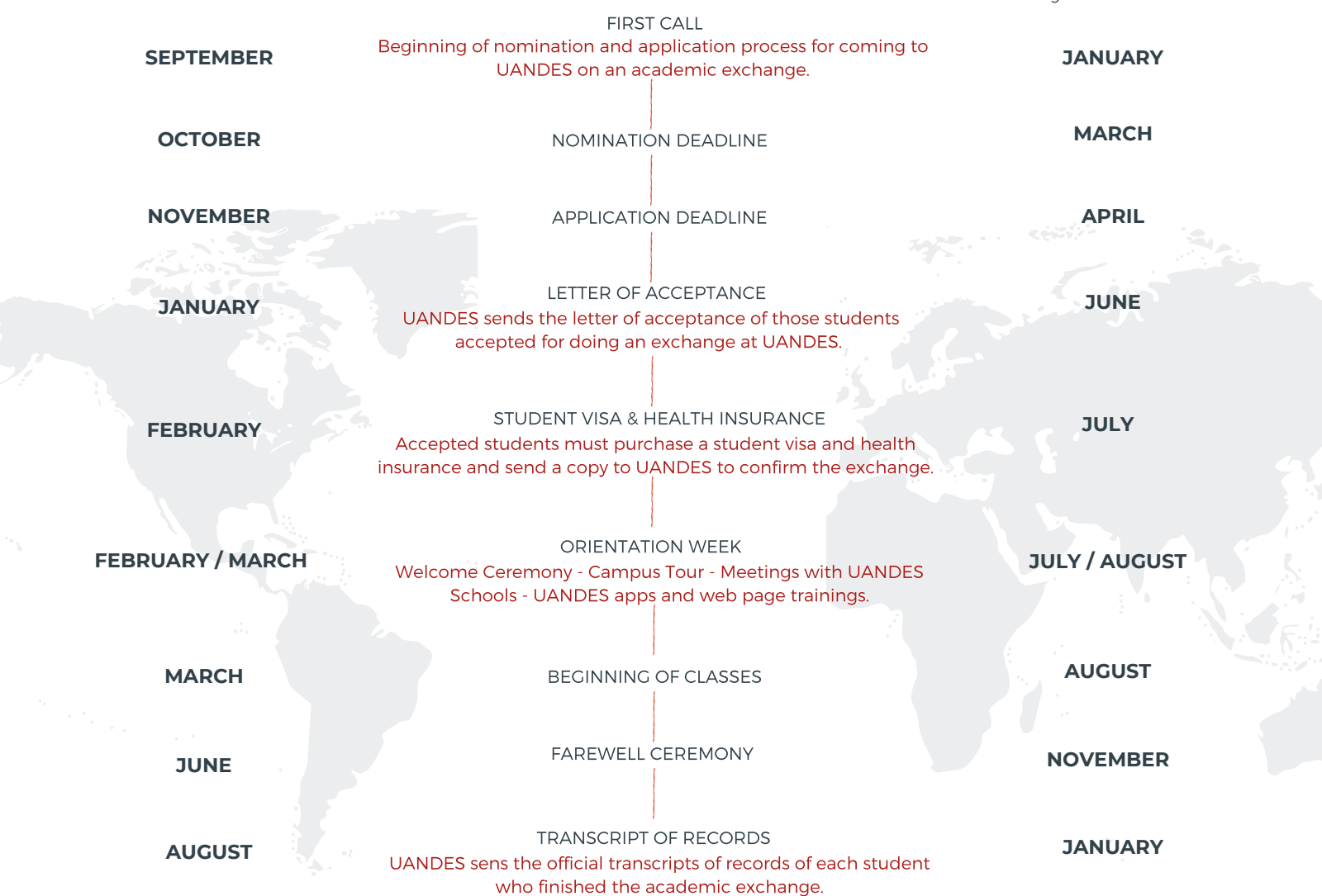

REQUIRED APPLICATION DOCUMENTS

- 1 Letter of Commitment**, signed by the student applying.
- ID size **picture of the student applying**, recent and in color.
- Passport photocopy** of the student, which must be **valid** throughout the entire stay in Chile.
- Academic records** of the student applying.
- Letter of intention**, one page long. If the student is applying for and Spanish-taught course, then the letter must be in Spanish.
- Language certificate**, Spanish and/or English, depending on the courses selected (only if the language is not native).
- Vaccine certificates**: depending on the School applied to (mostly for **health majors**).

All these documents **must be sent** the same day of completing the application form, to **incoming@uandes.cl**

ADDITIONAL REQUIRED DOCUMENTS

* HEALTH INSURANCE

Every student who comes to UANDES for an exchange must purchase a health insurance with international coverage valid throughout the entire stay in Chile and send a copy to incoming@uandes.cl.

* STUDENT VISA

Once received the Letter of Acceptance, the student must go to the Chilean consulate to request a student visa, the main mandatory requirement for doing an exchange at UANDES.

The student must enter to Chile with this document, otherwise he/she won't be permitted to study in UANDES. Within the first 30 days in Chile, the student must register the student visa in the PDI. For this, it is necessary to make an appointment in advance, so we recommend to make the reservation as soon as the student obtains the visa in his/her country of residence, as the process might take some time.

In the case of internships in the health area, a student visa will be required when the stay is longer than 90 days. If the stay is for less than 90 days, but practical activities will be carried out with patients, then a student visa is also required.

* CHILEAN ID

Once in Chile, and right after the registration of the student visa in the PDI, the student must obtain a Chilean ID with a RUT number (Chilean identification number). Only with this, the student will be granted with his/her official transcript or records at the end of the exchange.
