# Additional requirements/information

**SMS:** Students will receive a Newsletter with the instructions and link to the Online Registration System (IRK). They need to upload the required documentation there (among others Application for Accommodation - for those willing to stay in UO dormitories). Documents should be uploaded before the deadline (for the fall term – 15th June; for the spring term – 15th November).

The students are guided by Departmental Erasmus+ Coordinators for didactic issues as well as by the Office for Research and Project Management/International Mobility Team for practical issues like registration, residence permit, student ID, transportation options, accommodation, etc.

The teaching programme should be discussed and prearranged with the particular Erasmus+ Departmental Coordinator.
