Fall Semester

Nomination deadline: June 1st
Application deadline: June 15th
Period: September - December

Spring Semester

Nomination deadline: November 1st
Application deadline: November 15th
Period: January - April

application process

Nominated students are invited to complete their online application form and choose their courses.

Acceptance letters are emailed to students and copied to their local coordinator.

arrival & orientation

Buses and taxis are available from the airport and the train station.

A mandatory welcome day followed by an orientation programme is organised to discover Pau and its region.

nomination process

Nomination is done by the local coordinator through a dedicated form.

Programmes and academic information will be available on our website in the very near future.

before mobility

Our international office advises students on visa procedure, search for housing, banking partners and compulsory insurance policies.

Students receive their login and password to access the school digital system.

study abroad

application process for exchange students

Nominated students receive an email confirming their nomination and inviting them to complete their online form.

Required documents for application are :

- passport/identity card
- identity photo for student card
- last transcript of records
- B1 level language proficiency depending on programme (EN/FR)
- course registration form duly completed
- proof of health insurance

academic regulations

Students cannot mix courses from different programmes due to timetable collisions.

According to the academic regulations, an average of 10 out of 20 is the pass grade. Courses can be evaluated in different ways (final exam and/or continuous assessment).

Final exams are organized at the end of the exchange period. Depending on courses, if the final average is less than 10 out of 20, a resit exam may be organised. The grade obtained at the resit exam will be the final grade awarded to the course concerned.

Transcripts of records are sent to local coordinators within 2 months after the end of the semester. Certified copies can be sent upon request.

find an accommodation

Students have the possibility to find an accommodation through our partner [Studapart](#).

Login and password are sent once their application is validated. They will have the choice between private owner and student residence proposals.



mandatory insurances

In France, **3 insurances are mandatory** and advices will be sent to students for subscription:

- **health insurance** : for covering **medical, hospital, accident and repatriation expenses**. Concerning European students, their European Health Insurance Card + repatriation insurance (not covered by EHIC) will be sufficient.

Concerning non-European students, a private health insurance certificate for the whole stay abroad covering all these 4 risks will be requested.

- **civil liability insurance**: for covering **damage that you may unintentionally cause** to third parties in your private life.

- **housing insurance**: for covering your accommodation **against theft and other damage** that you may cause or suffer.

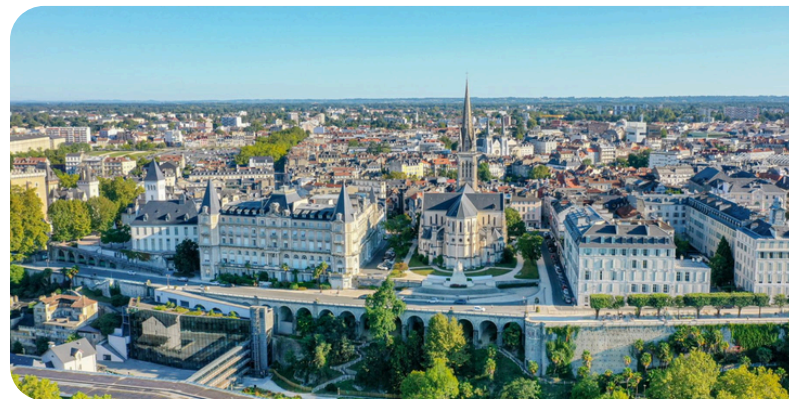
